#### 1) Introduction to OHSMS concepts as defined by the ISO 45001 standard

- Situating the organization's context with respect to the ISO 45001 standard.
- Determining the roles of players, objectives, and priorities in the context of the ISO 45001 standard.

- Planning your Occupational Health & Safety Management System (OHSMS) using the ISO 45001 standard.

*Hands-on work* : Quiz on concepts related to occupational health and safety. Debriefing and discussions with participants.

#### 2) OHSMS-related requirements and certification exam

- Overseeing documentation management in the context of implementing the ISO 45001 standard.

- Prioritizing and implementing prevention measures from the Occupational Health & Safety Management System.

- Assessing the compliance and performance of the actions taken.

- Spotting undesirable events in the enacted Occupational Health & Safety Management System.

- Implementing corrective actions to achieve continuous improvement.

*Hands-on work* : Quiz on the requirements of the ISO 45001 standard. Debriefing and discussions with participants.
